



Sunless Tanning Guide

For first time customers, please review the waiver below. We suggest you follow the guidelines below in order to maximize your tan. Print out and bring in to your first appointment.

1. Infinity Sun doesn't prevent your skin from burning in natural sunlight or in a tanning bed. Make sure to take proper precautions with UV light exposure.
2. It's recommended to do 1-2 sessions within 5-10 days to develop the desired color. To maintain tan, it's recommended to visit every 6-10 days. Healthier skin holds results longer.
3. Try to wait 12 hours before showering or engaging in a perspiring activity.
4. The porosity of skin may develop different results and longevity on individuals. It's also possible that different areas of skin might be lighter than others. This usually disappears after a few sessions and is minor.
5. Wait 12 hours before applying another session.
6. All tanning products are safe for skin and any adverse effects with prior self-tanning products are likely to create similar effects.
7. All active ingredients in Infinity Sun Solution are FDA approved. However, the FDA has not tested the ingredients for use in a spray on mist application. So far, the spray-on tanning process with the FDA approved solution is, therefore, not FDA approved. It is currently going through the process of being accepted.
8. Personal garments should be disposable so they do not get stained. But products are water soluble and should be able to be washed out.
9. Close eyes and mouth while being sprayed.
10. Disposable shower caps are recommended to refrain from the spray in the hair.
11. Those with asthma or respiratory conditions could be agitated. Please speak to a physician first.

12. Some ingredients may contain sugar base that could cause blood sugar levels to rise. Please speak with a physician if you are diabetic.
